1. Not Included: Unless specifically stated the following are not part of a travel package: Airfare, gratuities, meals not on liveboard boats, alcohol, scuba equipment, gas fills, arrival and departure taxes, travel to and from airports, parking, rental vehicles and other incidentals.

2. Package Changes: Packages are subject to change. You will be notified as soon as practical of any such changes that come to the attention of Huron Scuba.

3. Air Travel: If air travel is included in your package, each airline's policies applying to your ticket will control that portion of your trip price. If you cancel after that ticket has been purchased, any monies refunded by the airlines will be returned to you less seventy-five dollars.

4. Single Travelers: You will be paired with suitable roommates whenever possible. In all cases, each roommate has ultimate control over the people with which he or she may share accommodations. If you are the only occupant of a room/cabin designed for two or more people, you will pay a "single supplement" to cover those costs related to the other portion of that accommodation.

5. Surface and Underwater Supervision: Surface and underwater supervision is not provided by Huron Scuba or your trip leader. If such supervision is provided, it is done so by the local dive operator(s). If your trip leader is an active dive professional, you may independently contract with that person, through Huron Scuba, at an additional price to guide, supervise, or teach.

6. Non-Refundable: Huron Scuba signs contracts and makes non-refundable payments, reservations, and commitments based upon each specific reservation as well as the overall reservations, and may block others from coming on a trip to protect your reservation and the space available. Deposits, interim and final payments become non-refundable on the due date.

7. Final Payments: On the due date for your final payment, if you have not cancelled your space in writing at Huron Scuba, you owe that balance. It is your responsibility to make sure all payments are made in a timely manner. If you fail to make a payment, your space may be sold to another person without any corresponding refund to you. If you have any reason to cancel a trip after having paid any money, refer to your trip insurance policy (if purchased).

8. Trip Insurance: Insurance is sold by companies that charge a price and promise to reimburse or compensate you if certain unexpected events occur. Huron Scuba prices trips without trip insurance so that only those wanting those protections need to pay for them. Huron Scuba offers to help you purchase a travel insurance policy today and will do everything possible to assist in any claim you may make with respect to that policy. If you do not purchase trip insurance, you have elected to "self-insure" against such occurrences.

I further understand and agree on behalf of myself, my heirs and my estate that in the event of an injury or death during this activity, neither I nor my estate shall seek to hold PADI liable for the actions, inactions or negligence of HURON SCUBA, SNORKEL & ADVENTURE TRAVEL and/or the instructors and divemasters associated with the activity.

Liability Release and Assumption of Risk Agreement

I, _____, hereby affirm I am voluntarily engaging in the recreational activities planned for my trip to TOBERMORY ONTARIO, CANADA, which activities may include, but are not limited to, scuba diving, snorkeling, boating and _____. If I engage in scuba diving, I affirm that I am a certified diver or a student diver under the control and supervision of a certified scuba instructor, and that I am aware that skin and scuba diving have inherent risks which may result in serious injury or death. I certify that I am fully aware of and expressly assume all risks involved in scuba diving, snorkeling, boating and other activities in which I choose to participate.

I understand and agree that neither HURON SCUBA, SNORKEL & ADVENTURE TRAVEL, nor PADI Americas, Inc., nor its affiliate or subsidiary corporations, nor any of their respective employees, officers, agents, contractors or assigns (hereinafter referred to as "Released Parties,") may be held liable or responsible in any way for any occurrence on this trip which may result in personal injury, property damage or wrongful death or other damages to me, my family, estate, heirs or assigns that may occur as a result of my participation in this trip or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I further state that I am of lawful age and legally competent to sign this Liability Release Agreement, or that I have obtained the written consent of my parent or guardian.

I understand the terms herein are contractual and not a mere recital, and that I have signed this Agreement of my own free act and with the knowledge that I hereby agree to waive my legal rights. I have carefully read this agreement. I am aware that this is a binding contract which provides a comprehensive release of liability. However, it is not intended to assert any claims or defences that are prohibited by law.

This dive shop, itself, provides NO WARRANTIES express or implied and this equipment is accepted "AS IS". I have carefully read this agreement and release of liability and fully understand its contents. This document constitutes the final and entire agreement between this dive shop and the undersigned.

I understand how scuba diving equipment works and I have been fully instructed in its proper use. Any questions I have had about this rental scuba diving equipment have been satisfactorily answered. I agree to check this scuba diving equipment before each use and that I will not use this equipment if any parts are worn, damaged or missing.

The Dive Shop, owners and crew of the charter vessels shall not be liable for any loss or injury, howsoever, caused, whether by reason of fault or negligence of the owners or otherwise.
